## RULES

1. Market Days on Broadway hours of operation are 9:00 am – noon every Saturday beginning April 7<sup>h</sup> through the fall.
2. The Market will set up on the east side of Broadway.
3. A one-time \$50 fee will be required and will provide your 10 x 10 space for the entire season.
4. The market is a Farmers Market. Primary sales will be locally grown farm products, baked goods and crafts.
5. Farmers may collaborate with other local farmers to bring their product to market.
6. All items sold by the applicant will be reviewed and must be high quality, safe and an enhancement to the Market atmosphere.
7. Market Day staff will assign and manage reserved space.
8. Set up may occur as early as 8:00 am.
9. Vendors must bring their own tables, chairs, canopies and/or display racks. Easy pop up 10x10 tents are encouraged if your space is curb side.
10. Vendors must unload their supplies, products, etc. by their designated space and use the parking available in the RiverCenter Parking garage (entrance from Broadway or Front Avenue) or the Front Avenue parking garage (entrance from Front Avenue).
11. Display's MUST be presentable as determined by Market Day staff.
12. Any scale used for determining price must be calibrated.
13. Vendors will display their products in a clean and safe manner.
14. Vendors should operate their business in a professional manner at all times.
15. At the close of market, participants will clean their immediate area and remove all boxes, packing materials and trash.
16. This is not a discount market. Anyone engaging in price wars may be removed from the market.
17. Organically grown products must be certified by the State. You cannot use "organic" wording to describe your product unless it has been certified.
18. Vendors are required to display a sign identifying the farm or business by name and the location of the farm.
19. Market Day staff has the right to refuse vendor participation if the product does not fit the primary mission of the Market.
